**TERMS AND CONDITIONS**

On behalf of the President of India, sealed tenders are invited by the Office of the Member Secretary, Pondicherry Ground Water Authority, Puducherry-605 009 upto **1.00 p.m. on 24.08.2021** for the disposal of Condemned Vehicle Mahendira Bolero LX Jeep bearing Registration No.PY.01.G.2006 in as-is-where-is condition. The tenders received after the due date and time will not be accepted. **Only, the GST registered candidate alone can participate in this auction.**

2. The sealed tenders offering the rate for the purchase of Mahendira Bolero LX Jeep should be sent to the Office of the Member Secretary, Pondicherry Ground Water Authority, No. 15, III Cros(Extn), Mariamman Nagar, Karamanikuppam, Mudaliarpet Post, Puducherry - 605 004 in a sealed cover (size 26 x 11 cm) with the following superscription. "Tender for the purchase of condemned Mahendira Bolero LX Jeep ". The envelope should also bear the name and address of the firm and seal of the tenderer, if any.

3. An amount of Rs.2,500/-(Rupees Two Thousand Five hundred only) towards the Earnest Money Deposit (EMD) in the form of Demand Draft drawn in the favour of "The Member Secretary, Pondicherry Ground Water Authority Puducherry", should be accompanied with the tender.

4. The Earnest Money Deposit (EMD) will be returned to the unsuccessful tenderers soon after finalization of the tender. Any amount paid less than the Earnest Money Deposit fixed will result in cancellation of the tender.

5. The rate should be quoted only in the prescribed tender form enclosed, failing which, the tender will be rejected.

6. The condemned Vehicle Mahendira Bolero LX Jeep to be auctioned is available for inspection by who have purchased the tender documents, during office hours at Office of the Member Secretary, Pondicherry Ground Water Authority, No. 15, III Cros(Extn), Mariamman Nagar, Karamanikuppam, Mudaliarpet Post, Puducherry - 605 004 .

7. ***Sealed Tender will be opened first by the Tender Committee at 3.00 p.m. on 25.08.2021*** at the Office of the Member Secretary, Pondicherry Ground Water Authority, No. 15, III Cros(Extn), Mariamman Nagar, Karamanikuppam, Mudaliarpet Post, Puducherry - 605 004 in the presence of the tenderer or their authorized representatives who choose to be present and then if necessary open auction will be conducted. In case of participation by representatives, the authorization letter issued by this office should be submitted to this office before 3.00 pm on only permitted representatives will be allowed to participate in the auction.

8. The highest bid among the sealed tender or open auction as decided by the Tender Committee will be accepted as the sale value.

9. If the opening day of the tenders happens to be a holiday, the same will be opened on the next working day at 03.00 p.m.

10. Acceptance of the highest bid will be intimated to the successful tenderer, once the auction is finalized.
11. GST: The highest bidder should pay the GST amount in force to the Commercial Tax Department through Reverse Charge Basis.
12. The successful tenderer should deposit 25% of the entire amount immediately after the acceptance of his highest bid on the same day. The remaining 75% amount should be paid within 24 hours failing which the demerger fees will be collected.
13. The condemned vehicle will be delivered to the successful tenderer only after payment of the entire amount including taxes.
14. After payment, the successful tenderer should take delivery of the condemned vehicle at his own risk and cost within 48 hours failing which a ground return of 1% per day will be recovered for the whole or part thereof removed after the due date.
15. Claims on quality and quantity of the auctioned materials will not be entertained once the tender is over.
16. **PAYMENT:** Payment should be made either by cash or Demand Draft of any Scheduled Bank drawn in favour of the Member Secretary, Pondicherry Ground Water Authority, Puducherry – 605 004 payable at Pondicherry.
17. **LOSS or DAMAGE:** This office will not be responsible either for the safe custody or for any loss or damage of the vehicle once disposed off after cash payment.
18. **GENERAL CONDITIONS:**
  - (a) The highest tenderer is responsible for the act done either by him or by his representatives
  - (b) In case of any dispute it should be clearly understood that the decision of the Tender Committee shall be final.
  - (c) The tender committee reserves all the rights to reject any tender or all without assigning any reason thereof and the decision of the tender committee will be final and binding on all.
  - (d) The highest tender once accepted is not transferable.
  - (e) The tenderers are strictly forbidden to indulge in any group discussions or quarrel inside the hall during auction. If, violating they will not be allowed to participate in the tender / auction but sent out, instead.
  - (f) All the tenderers are deemed to have read and accepted the terms and conditions herein mentioned.
